Cancellation:

If cancellation is requested all payments made to *Signature* FOUNTAINS are non-refundable.

Responsibilities:

Client is responsible for acquiring *Signature* FOUNTAINS access to set up area at least one hour prior to the scheduled event for set up, and one hour upon conclusion of our service, for take down. Client is responsible for providing a sturdy, level table that is capable of supporting the *Signature* FOUNTAINS Chocolate Fountain and additional items. Client is responsible for providing table linens. The *Signature* FOUNTAINS Chocolate Fountain requires at least one 120 volt circuit within 10 feet of the desired set up area that adheres to the safety standards and supplies to us at least 15 amps. Client accepts full responsibility and is liable for any damages, injuries or delays that may occur as a result of failure to comply with these provisions.

Liability:

Signature FOUNTAINS shall not be liable for any injury, loss or damage directly or consequently arising out of the use of the *Signature* FOUNTAINS Chocolate Fountain, whether used singularly or in conjunction with any other equipment. Client will indemnify *Signature* FOUNTAINS against, and hold *Signature* FOUNTAINS harmless from all claims, actions, proceeding, cost, damages, and liabilities, including attorney fees, arising out of, connected with, or resulting from the use of the *Signature* FOUNTAINS Chocolate Fountain.
